

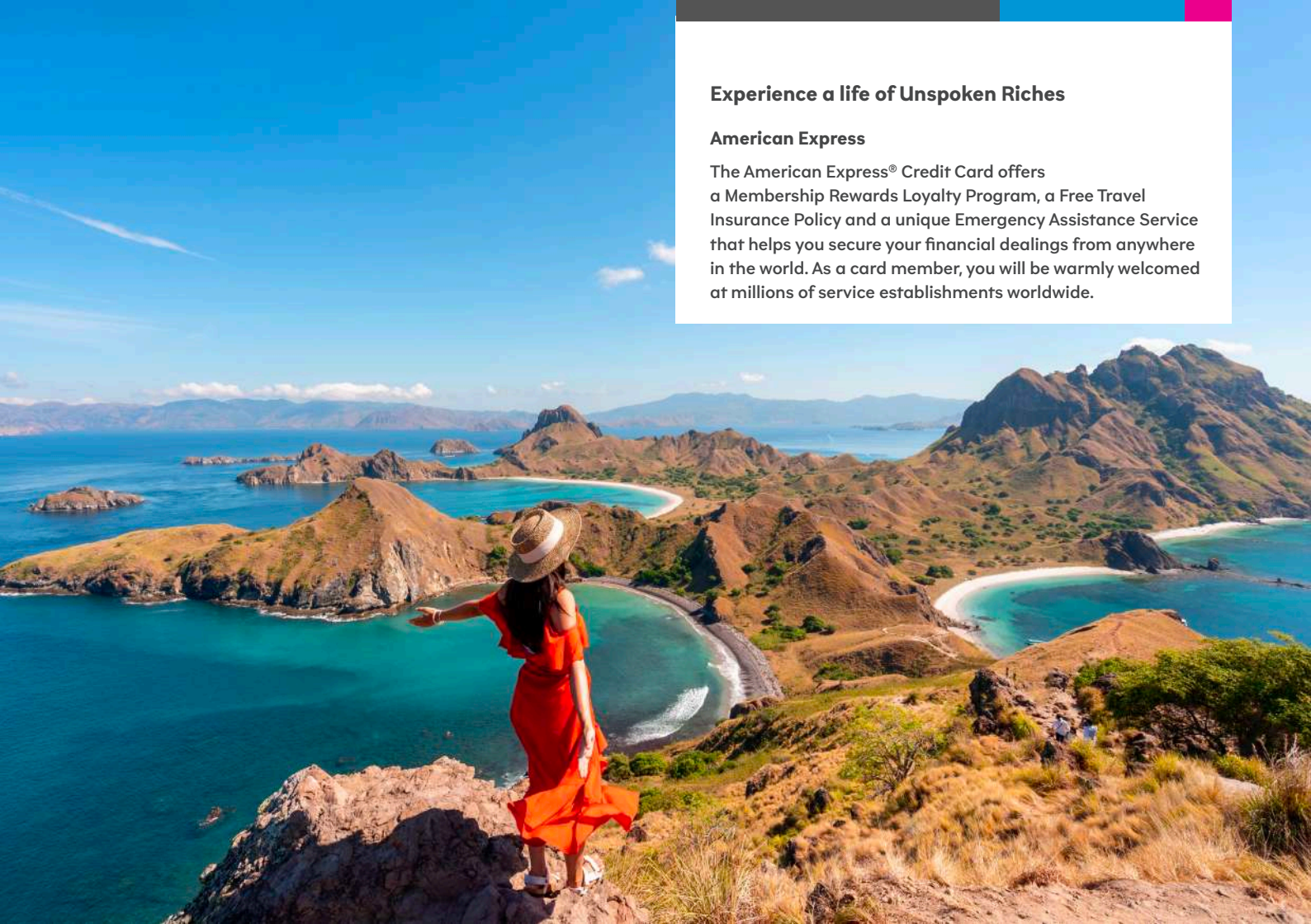

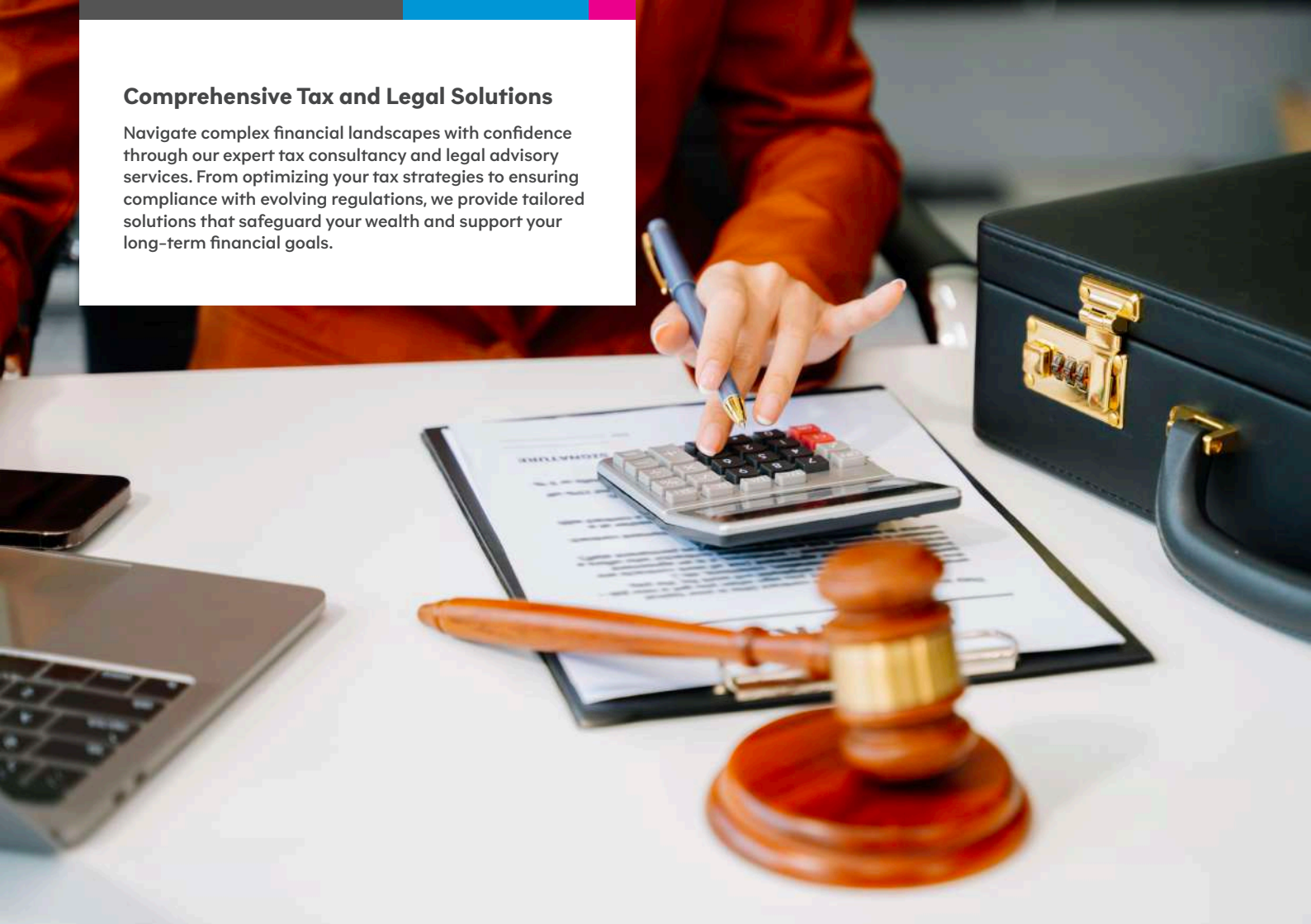

Eligibility Requirement

Eligibility Requirement for Nations Trust Bank Private Banking Global Membership

The account holder should maintain either one of the eligibility criteria:

- Remit USD2500 monthly to Nations Trust Bank Account
- A minimum monthly average credit balance of LKR 10 million in any deposit account along with a monthly average balance of at least LKR 10,000 in a current or savings account

OR

- A total average balance of LKR 20 million in both deposits and loans along with a monthly average balance of at least LKR 10,000 in a current or savings account

OR

- Remit a net salary of LKR 500,000 per month to Nations Salary Saver, savings or current account.
- Government securities with 25Mn Investment +250K in CASA
